I understand the following:

1. The Judges decision in each category is final.
2. No judges' scoresheets will be provided to contestants after the pageant. To allow the pageant to move in a timely fashion without major delays the judges will score each contestant in each category then turn in their score sheets to the Judges Chairperson for instant tallying.
3. Entry Fees are non-refundable.
4. The pageant will be broken into two groups for competition day.
Group A will consist of Baby Miss, Toddler Miss, Tiny Miss, and Petite Miss
Group B will consist of Little Miss, Junior Miss, Teen Miss, Miss, and Elite Miss
5. Each contestant will compete in two categories on stage, fun fashion, and dress/evening gown. There will be fun fashion and evening gown winner for each age group.
6. Each Contestant will submit a photo for the judges to select a winner in each age group.
7. All Winners will take a group photo at the end of the second pageant and that photo will be sent to the local newspapers.
8. All Winners and Top Fives will be posted to the Miss Chimney Rock Pageant tab under the Miss Lake Martin Alabama and Miss Lake Martin Alabama's Teen Official Preliminary to Miss Alabama and Miss Alabama's Teen website, Facebook, and Twitter pages.
9. **All 2025 winners will return to crown the 2026 winners and therefore are unable to compete in the 2026 pageant.**
10. All Winners agree to attend if available the 2026 Miss Lake Martin and Miss Lake Martin Alabama's Teen Pageant and any other scheduled events by the Directors.
